### **Background**

The SEGRA Foundation exists to advance rural, remote and regional Australia. We are an independent and non-partisan network of Australians who connect, promote and empower regional communities. We work collaboratively with all peak regional bodies and our specific remit is to support and empower "the doers".

SEGRA is a vehicle to help regional people take the initiative and control of their own economic development destinies. We share learnings and identify key decision makers, processes and points of access in government, and the corporate sector, to turn ideas into reality and activate real solutions to challenges.

The Foundation held the National Regional and Economic Development Summit over two days in July in Toowoomba, Queensland. The event brought together national, state and local leaders, all levels of government and decision makers to collectively solve the unique challenges across the regions. The Summit encouraged grass roots contributions and as a result, SEGRA is now taking the next step and hosting a drop-in session at Parliament House, Canberra to highlight positive, practical and specific solutions from across regional Australia that will improve living and working in regional, rural and remote communities.

#### The Plan for the SEGRA In House Session

- Theme: Place Based Economic Development: Shaping the Future of Rural, Regional, and Remote Australia
- Objective: to present a selection of case studies from #RRR Australia that provides solutions
  to current challenges. The case studies must have been implemented in the regions,
  transferrable to other communities, and/or advocate for a positive change of policy or work
  innovatively within an existing framework
- Format: a 'drop in session' for members of Parliament and policy advisors to learn and connect
